

MEMORANDUM OF UNDERSTANDING

**KUNMING UNIVERSITY OF SCIENCE & TECHNOLOGY, KUNMING,
YUNNAN, THE PEOPLE'S REPUBLIC OF CHINA**

AND

**RAJAMANGALA UNIVERSITY OF TECHNOLOGY PHRA NAKHON,
BANGKOK, THE KINGDOM OF THAILAND**

The President of Kunming University of Science & Technology, Kunming, Yunnan, The People's Republic of China and the President of Rajamangala University of Technology Phra Nakhon, Bangkok, The Kingdom of Thailand, hereby enter into an agreement to promote the academic cooperation and exchange between their two respective institutions, based on the principle of equality and reciprocal benefit.

The scope and procedural details of this Memorandum of Understanding are as follows:

I. Field of Cooperation

Both institutions agree to work together in teaching and research in the area of science and technology, including the cooperation and exchange concerned.

II. The Memorandum of Understanding covers the following:

- Exchange of academic staff, researchers, and students,
- Exchange of university publications and information,
- Collaborative research projects and joint workshops,
- Collaborative programs enhancing curricula and teaching in both parties, and
- Other activities such as deemed appropriate by mutual consent.

III. Any other forms of cooperation and activities shall be negotiated and mutually agreed upon in written agreements by representatives of both parties.

IV. This Memorandum of Understanding specifies general areas of potential cooperation. It is understood that the enactment of this Memorandum of Understanding shall require specific governing conditions and framework. Additional Memoranda of Agreements detailing the governing conditions and framework, including financial arrangements and other requirements, shall be agreed upon prior to the commencement of any activities.


V. If any disputes arise during the execution of this Memorandum of Understanding, both institutions, on the basis of mutual benefit and mutual trust, shall resolve them through friendly consultation.

VI. This Memorandum of Understanding shall be effective from the date duly signed by the representative of each respective institution and remains in effect for five (5) years, unless either university proposes termination in a written notice at least six months prior to the termination date. Under such circumstances, any on-going activity under this Memorandum of Understanding

should be allowed to continue until completion under the conditions applying when notice was given. The Memorandum of Understanding may be amended or extended by mutual consent of both parties; any amendment and extension to the Memorandum of Understanding must be formal communication between the two institutions.

VII. All other linguistic versions are provided for information only. Only the English version of this Memorandum of Understanding and the subsequent Memorandum of Agreement has binding effect.
